# India Calling Conference 2022

on May 6, 2022



The Embassy of India invites business to participate in the Annual IMC India Calling Conference for the year 2022 which will be held virtually on a digital platform on the theme '[Unleashing Opportunities - Why Invest in India](#)' on Friday, May 06, 2022 by IMC Chamber of Commerce and Industry, Mumbai, India (IMC - formerly Indian Merchants' Chamber).

It is an annual feature established by IMC to provide networking platform for Indian and global players to come together and debate, share insights and explore potential investment opportunities and collaborations. Invest India has extended their support to the Conference like last year's India Calling Conference.

Since we are still not completely out of the shadow of the pandemic, this year again the India Calling Conference will be held on a customized digital platform allowing for b2b networking and access to newer markets during the Conference.
